

## LEGAL NOTICE <https://www.unicajabaloncesto.com/>

### 1. Legal information

These provisions regulate the use made by internet users of the website <https://www.unicajabaloncesto.com/> (the "**Website**") owned by BALONCESTO MÁLAGA, S.A.D. ("**Unicaja Baloncesto**").

Unicaja Baloncesto has its registered office at Avenida Gregorio Diego, 44, 29004 Málaga and N.I.F. A29575933. The company is registered in the Mercantile Registry of Malaga in volume 2012, book 925, folio 89, page MA-11333.

Access to the Website is free of charge, except for the cost of the connection through the telecommunications network that is provided by the access provider contracted by the users.

The contracting of services through the Website will be subject to the conditions and prices established at any time on the Website.

### 2. Acceptance of Terms and Conditions

Access, through any device, to the Website confers the status of user of the Website ("**User**"), implying, at the same time, the express acceptance by the User of these terms and conditions, as well as of the Contracting Conditions that, where applicable, are established on the Website.

The terms and conditions will be applicable in the relationship between Users and Unicaja Baloncesto, without prejudice to the fact that there may be other specific conditions between the parties that replace, complement and/or modify them, and which must be accepted by the User before the start of the provision of the contracted service.

The terms and conditions of the Website are limited in duration at the time when the User is connected to the Website or using any of the services provided through it. Consequently, the User must carefully read the terms and conditions, including the Cookie Use Policy and the Terms and Conditions of Contract, each time they use the Website, as they may be subject to modifications of any kind.

### 3. Terms of use of the Website

#### 3.1. Use and content

The User undertakes to use the Website correctly and diligently, in accordance with the provisions of these conditions of use and the applicable regulations. The User will be liable to Unicaja Baloncesto or third parties for any damages that may be caused as a result of non-compliance with this obligation.

In accordance with the foregoing, the User may not use the Website for any purpose other than that for which it was created or for purposes that threaten the property or interests of Unicaja Baloncesto or third parties, or that, in any other way, damage, damage, overload or render useless the networks, servers and other computer elements (hardware and software) of Unicaja Baloncesto or third parties.

In particular, Users undertake to:

(i) Not to use the content or services of the Website in any way that may contravene current legislation.

(ii) Not to reproduce, copy, distribute, make available, publicly communicate, transform or modify the content of the Website, except in cases authorised by the applicable regulations or expressly authorised by Unicaja Baloncesto or by whoever holds the corresponding exploitation rights.

(iii) Not to violate, in any way, the intellectual and/or industrial property rights belonging to Unicaja Baloncesto or any third party.

(iv) Not to use the information of any kind obtained through the Website (such as data of other users), to send advertising or any other act for commercial purposes, either massively or individually, nor to market or disseminate such information in any way.

(v) Not to destroy, alter, disable, introduce viruses, programs or applications, or in any other way, damage the content found on the Website.

### **3.2 Links**

The introduction of links to the Website from other websites must comply with the provisions of these provisions, without ignorance of them avoiding the responsibilities derived from the Law:

(i) The website that establishes the link must faithfully comply with applicable legislation, may not make false, inaccurate or incorrect statements about Unicaja Baloncesto, may not state that Unicaja Baloncesto has consented to the insertion of the link or that it collaborates, in any way, with the owner of said website (unless prior and express authorisation from Unicaja Baloncesto), nor may they use the trademark or distinctive signs of Unicaja Baloncesto.

(ii) Under no circumstances may the Website be made available or linked to its own content or that of third parties that is illicit, harmful or contrary to morality, public order and good customs (pornographic, violent, racist, etc.), which induce or may induce the false conception that Unicaja Baloncesto subscribes, endorses, adheres to or in any way supports, the ideas, statements or expressions, lawful or illegal, of said website, or that are inappropriate or not pertinent to the activity of Unicaja Baloncesto.

(iii) The link will only link to the home page of the Website but may not reproduce it in any way (*in-line links*, copy of texts, graphics, etc.).

(iv) It is, in any case, prohibited, in accordance with the applicable legislation at any time, to establish frames of any kind (*frames*) that surround the Website or allow the visualization of the contents through Internet addresses other than those of the Website and, in any case, when they are viewed together with content outside the Website in a way that produces, or may cause error, confusion or deception in users as to the true origin of the service or contents, may involve an act of unfair comparison or imitation, may serve to take advantage of the reputation of the brand and prestige of Unicaja Baloncesto, or in any other way may be prohibited by current legislation.

#### **4. Exclusion of liability**

Without prejudice to the provisions of other sections of these terms and conditions, Unicaja Baloncesto will not be liable, under any circumstances, for:

(i) The lack of quality, veracity, accuracy or specialization of the information hosted on the Website, nor by the decisions that Users adopt based on the information provided on the Website.

(ii) Damages that may be caused to Users due to failures or disconnections in telecommunications networks that cause the suspension, cancellation, interruption or inaccessibility of the services of the Website. In this sense, access to the Website requires third-party services and supplies (telecommunications networks) whose operation is not the responsibility of Unicaja Baloncesto.

(iii) Damages caused by fraudulent use of the User's account or by interference by third parties in the Website that may cause alterations or loss of all or part of the content of the Website. In this sense, it is the User's responsibility to make available suitable tools that detect and disinfect harmful computer programs.

(iv) Damage caused to the computer equipment of Users or third parties during access, browsing or the provision of services through the Website.

#### **5. Reservation of rights**

Without prejudice to the provisions of other sections of these terms and conditions, Unicaja Baloncesto reserves the right to:

(i) Modify, at any time and without prior notice, the design, images, operation and configuration of both the content and the Website and its features.

(ii) Modify, at any time and without prior notice, the content of these terms and conditions, by publishing the new terms and conditions on the Website.

(iii) Cancel the registration account of any User who misuses the Website or the account itself, in breach of these terms and conditions.

(iv) To take any legal action of any kind against Users and/or third parties who fail to comply with the provisions of these terms and conditions.

#### **6. Privacy Policy**

#### **7. Industrial and Intellectual Property**

The texts, images, icons, links, photographs, graphic design, source codes and other content, including audiovisual or audio, on the Website are the exclusive intellectual property of Unicaja Baloncesto or, where appropriate, of third parties. The User has no
